Sealed tenders are invited from the experienced contractors in prescribed tender-documents. Details are as follows:

1.	<u>Description of work</u>	Polyurethane painting of WAG-9 Electric locomotives at Electric Loco Shed, Gomoh
2.	<u>Quantity</u>	20 (Twenty) Locos.
3.	<u>Completion period</u>	6 (Six) months.
4.	<u>Approximate cost of work</u>	Rs.44,91,310/- (Rupees Forty four Lakh ninety one thousand three hundred ten only).
5.	<u>Earnest Money</u>	Rs.35,000/- (Rupees Thirty five thousand only). The tender must be submitted along with Earnest money in acceptable form as mentioned in the tender documents. Tender received without the prescribed amount of Earnest Money is liable to be summarily rejected.
6.	<u>Cost of Tender-documents (Non-refundable)</u>	Rs.1,500/- (Rupees One thousand five hundred only).
7.	<u>Period of sale of tender-documents</u>	From 13-12-2005 to 28-12-2005, on all working days at working hours (09:00 Hrs. to 17:00 Hrs.).
8.	<u>Mode of purchasing Tender-documents</u>	

Tender-documents may be obtained from the office of Senior Divisional Electrical Engineer/TRS /East Central Railway/ Gomoh, Electric Loco shed, Gomoh on production of 'Cash-Receipt' or 'Demand Draft' for the sum towards cost of tender-documents. Cash-Receipt may be obtained by depositing Rs.1,500/- with Divl.Cashier /East Central Railway /Dhanbad or Chief Cashier /East Central Railway /Hajipur. Demand Draft should be made in favour of 'Financial Advisor & Chief Accounts Officer /East Central Railway / Hajipur', issued by the State Bank of India or any of the Nationalised or Scheduled Banks, duly constituted and governed by RBI stipulations. For tender-documents to be obtained by Regd.Post, Rs.100/- (Rupees One hundred only) should be paid extra and the 'Cash-receipt' or 'Demand Draft' should be sent to the office of 'Sr.Divl.Elect.Engg./TRS/E.C.Rly./GMO', P.O.-Gomoh, Dist.-Dhanbad, PIN-828401 (Jharkhand) with specific request to send the tender-documents by Regd. Post. However, the Railways take no responsibility for delay, loss or non-receipt of the tender-documents sent by Regd. Post.

9. Minimum eligibility criteria:
- a) The tenderer should have completed in the last three financial years (i.e. current year and three previous financial years) at least one similar single work for a minimum value of 35% of advertised tender value of work.
 - b) Total contract amount received by the tenderer during last three years and in the current financial year as per ITCC or attested certificate from the employer / client or audited Balance Sheet / financial statement duly certified by Chartered Accountant, should be a minimum of 150% of advertised tender value of work.

11. Date of opening of tender 29-12-2005, at 14:30 Hrs.
12. Place of tender-opening Office of the Sr.DEE/TRS/Gomoh.
